








AFPMBAI, THEN AND NOW...

Abuluyan, or passing of the hat for voluntary financial assistance to the families of fellow soldiers who got killed-in-action was a tradition that gave rise to the Armed Forces of the Philippines Mutual Benefit System. The system was created under the Letter Directive from the Headquarters of the National Defense Forces on February 22, 1949 to provide protection and security to its forces after the World War and during the height of the anti-dissident campaign. The need to have a corporate existence eventually emerged and led to a non-stock, non-profit corporation - Armed Forces of the Philippines Mutual Benefit Association, Inc. on September 1, 1965. The name was later changed to the Armed Forces and Police Mutual Benefit Association, Inc. (AFPMBAI).



AFPMBAI ANNUAL REPORT 2023

The Association was registered with the Securities and Exchange Commission (SEC) on January 13, 1966. In March of the same year, the Insurance Commission also granted the Association the authority to start its mutual benefit operations. With the aim of further improving the services to the uniformed men and women, President Ferdinand E Marcos issued Letter of Instruction No. 333 placing the AFPMBAI under the management of the AFP Chief of Staff. It thereafter established the Armed Forces and Police Savings and Loan Association, Inc. (AFPSLAI) on December 1, 1972.

For two consecutive years in 2022 and 2023, AFPMBAI has received the prestigious Golden Arrow Award from the Institute of Corporate Directors (ICD) and the Insurance Commission. It ranked 22nd out of 114 insurance companies and 5th out of 35 mutual benefit associations in 2023. This was based on the ASEAN Corporate Governance Scorecard (ACGS), whose scoring system rates the performance of companies in terms of their corporate governance.

The Association remains to be the top among all MBAs in the country in terms of assets and legal policy reserves.





WHAT WE OFFER TO OUR MEMBERS

AFPMBAI takes pride in offering a comprehensive array of products and services tailored to meet the diverse needs of its valued members. From life insurance plans providing peace of mind to real estate loans facilitating dreams of homeownership, the Association is committed to safeguarding and enhancing the financial well-being of its members and their families.

LIFE INSURANCE

AFPMBAI offers a comprehensive set of life insurance products designed to provide financial security and peace of mind to its members. Among its top offerings is the MBAI Protek, a basic membership insurance plan that ensures coverage from the date of entry into service. Additionally, the MBAI iProtek extends protection to spouses and dependents, retirees, and civilian/non-uniformed personnel with various plan options catering to different demographics. With Whole Life and 20-Pay Life plans, members enjoy lifelong protection and financial benefits.

SAVINGS PLANS

AFPMBAI's savings plans provide members with guaranteed savings and additional protection over specified terms. Endowment Plans offer flexibility and security, with dividends accruing from the fourth year onwards. Saver's Protection Plus, a 10-pay 15-year endowment plan, ensures members' financial goals are met with guaranteed 20% yearly cash bonuses starting on the 10th year, while providing added benefits for their families in case of unforeseen circumstances.

RETIREMENT AND EDUCATIONAL PLANS

The Endowment at Age 56 (E-56) and MBAI Achiever cater to members' retirement and their dependents' educational needs, respectively. These plans offer a combination of protection and savings, ensuring members and their families are financially prepared for the future.

GROUP LIFE INSURANCE

AFPMBAI's Group Life Insurance programs provide coverage for employees of specific groups, offering additional financial security and peace of mind. The Group Yearly Renewable Term Insurance and Special Group Term Insurance further enhance coverage for specific groups within the uniformed services.

MBAI 5ECURE

For those seeking affordable short-term protection, MBAI 5 ecure offers a 5-year term insurance plan with maximum coverage and benefits, ensuring financial stability for members and their loved ones

INSURANCE LOANS

AFPMBAI offers various loan options to its members, including Salary Loan, Policy Loan, Equity Loan, Member's Educational Assistance Loan (MEDAL), Expanded Salary Loan, and Emergency Loan. These loans provide financial assistance tailored to the unique needs of members, ensuring access to funds when needed the most.

REAL ESTATE LOANS

AFPMBAI's Real Estate Loans enable members to achieve their housing goals with flexible and affordable payment options. Whether it is purchasing a house and lot, mortgage financing, or pre-retirement real estate loans, AFPMBAI ensures members have access to housing solutions that fit their needs.

In 2023, the Association has focused on enhancing existing offerings and developing new ones to deliver innovative and reliable financial solutions to its members. While it has been giving extra financial assistance benefits with no extra premiums required, such as Burial Cash Assistance, Wounded-in-Action, and Battle Injury Assistance, a Daily Hospital Income Benefit of P1,000 per day (maximum of 45 days per year) will soon be offered as well to members who are hospitalized due to sickness, accidents, and other causes in the performance of duty.

As another year of service and growth ended, AFPMBAI extends its heartfelt gratitude to its valued members for entrusting the Association with their financial needs. With a steadfast dedication to service, excellence, and member satisfaction, the Association stands ready to support its members' financial journey every step of the way.

WHAT OUR MEMBERS ARE SAYING

MEMBERS' FEEDBACK ON PRODUCTS AND SERVICES

Dedicated to delivering exceptional service and products, AFPMBAI conducted a comprehensive customer satisfaction survey (CSAT) in partnership with Kantar Philippines in 2023. With a 95% confidence level, the CSAT survey aimed to measure customer satisfaction levels regarding the Association, its products, and services. It covered a weighted representative sample of 539 respondents from the various branches of service in 10 locations nationwide.

OVERALL SATISFACTION

The majority of respondents expressed high levels of satisfaction with the Association, with 97% of the respondents rating their experience as either "satisfied" or "very satisfied." This demonstrates the Association's continuous commitment to meeting and exceeding customer expectations.

PRODUCT QUALITY

One of the standout areas of positive feedback was regarding the quality of products. Respondents consistently praised the security, functionality, and affordability of the products. Here are some actual comments from survey respondents:



PRESIDENT'S REPORT

REPORT OF THE PRESIDENT AND CEO

For 2023, AFPMBAI started the year in full gear aiming *sustainability thru collaboration, innovation and growth.* It embraced all the challenges to raise its bar of standards, breaking ground to adapt to the changes needed to improve its services and business processes in the spirit of innovation.

Inspired by an attitude of gratitude, withstanding the onslaught of the pandemic, the Association continued its commitment of dedicated service to its members. The great leap of bringing its products and services closer to the members was realized during this year with the full installation of all the Regional Sales and Service Centers (RSSCs).

Guided by the AFPMBAI's vision to become the undisputed leader and the industry standard among mutual benefit associations, the Association kept the balance on good governance and member satisfaction thru strategic corporate initiatives on the different perspectives of Social Impact, Financial, Customer, Internal Process, and Learning and Growth.

SOCIAL IMPACT

The AFPMBAI has succeeded in strengthening its corporate image and social responsibility through its various donations and handovers made nationwide during its caravans/information drives. The AFPMBAI as well created a positive influence to its members thru financial literacy talks and livelihood seminars.

As published in Manila Standard and Malaya, the AFPMBAI reached the P2 Billion milestone in CSR projects manifested through flagship programs on education, health, and general welfare.

The Association's key donations for the year included the PA Transient Facility handover and the future PNP Grandstand ground breaking in Quezon Province. It is also noteworthy to mention that several of the Grants for Dependents (GRADE) Program Scholars successfully graduated from their respective courses with honors. These scholars are dependents of the AFPMBAI's MUP members who were either killed-in-action, died in the line of duty or discharged due to complete disability.

Among all these CSR endeavors, AFPMBAI received several recognitions as appreciation from various offices, such as the Office of the Adjutant General of the AFP, Finance Center of the Philippine Army, AFP Health Service Command, and Philippine Navy Personnel Management Center, to name a few.





FINANCIAL PERSPECTIVE

In 2023, the Association was honored with the prestigious Golden Arrow Award from the Institute of Corporate Directors (ICD) for the second time covering 2022 CGS assessment. This is a manifestation of the AFPMBAI's effective internal control and risk management systems as reflected by the increased rating of the Association 's Corporate Governance Score of 84.88%, a 0.56 point increase from the previous year.

This recognition is bestowed by the ICD, an accredited evaluator appointed by the Insurance Commission (IC). The AFPMBAI ranked 22nd out of 114 companies, and 5th out of 35 MBAs. The Association was granted One Golden Arrow for achieving a governance rating of over 80%.

For the period, the Association has released loans from policy, equity, salary and MEDAL amounting to P11.94 Billion; Claims of matured policies, bonus, termination and disability benefits amounting to P1.45 Billion; Death benefits worth P256.35 Million and Comprehensive Financial Assistance Benefits (CFAB) worth of P29.56 Million. This is the financial assistance given to cover those killed in action (KIA), wounded in action (WIA), or those who incurred injuries or illnesses while performing their duties. This is given at no added cost to the monthly premiums paid by the regular members for their existing policies.

In addition, to ensure the financial security of its members and their families, AFPMBAI continues to provide Real Estate Housing, Mortgage, and Pre-retirement Mortgage Loans. During the reported period, grants for Real Estate Mortgage Loans totaled P376.46 Million.

CUSTOMER PERSPECTIVE

In pursuit of AFPMBAI's commitment to offer members responsive and innovative products along with comprehensive benefits, the Association initiated a series of product patronage promotions involving its members:

- "INSUride" raffle promo which was extended to members who availed permanent and individual insurance plans;
- "Beat the Heat" promo served as AFPMBAI's Summer Giveaway, providing incentives to those who utilized real estate loans;
- "Watch Up Member Promo" awarded to members upon approval of loans under the Enhanced Salary Loan Program; and
- "MoneyCARsary" raffle promo allowed members to earn entries for every P100,000 loan or insurance purchase in time for the AFPMBAI's anniversary celebration

The Member's Referral Incentive/Reward known as "Kaagapay Member to Member Referral Promo" remained in effect until the middle of the year. It offered rewards to members who successfully referred others to sign up for MBAI 5ecure and MBAI iProtek.

During this period, the Association also obtained approval from the IC for the new Group Credit Redemption Life Insurance, covering the outstanding balances of AFPMBAI loans taken out by members. The reduced rates will result in higher loan proceeds for our offerings and lower amortization payments.

With the full implementation of the decentralized processes in the Regional Sales and Service Centers (RSSCs), members can now enjoy processing of their insurance and loan applications, death and disability claims, and termination benefits, as well as requests for copies of insurance policies, certifications, and clearances. The RSSCs are strategically located in the following areas:

- Northern Luzon (NOLRSSC) Cabanatuan City, Nueva Ecija
- Southern Luzon (SOLRSSC) Legazpi City, Albay
- Visayas (VRSSC) Cebu City, Cebu
- National Capital Region (NCRSSC) Quezon City (Home Office)
- Mindanao (MRSSC) Davao City, Davao





INTERNAL PROCESS PERSPECTIVE

Through innovative measures geared towards improving business processes and services, AFPMBAI has successfully completed the 4th phase of digitizing AFPMBAI records using the Document Management System (DMS).

For the Real Estate Accounts Monitoring System (REAMS), AFPMBAI has initiated the data migration process to facilitate the management of real estate loan payment postings.

The Association also fully integrated Zendesk as its customer service ticketing system, providing a comprehensive solution to efficiently address the inquiries and concerns of its members.

Furthermore, as part of measures to achieve a fully integrated system and pursue digital transformation, the Association accomplished the following in addition to its IT framework:

- Procurement of Whispir, an online communications management platform
- Completed the initial development of the Claims Register Module
- Completed the initial development of the Channel Development and E-commission system

AFPMBAI strengthened its channel development efforts by collaborating with various payment facilities, providing members with increased flexibility in paying amortizations and receiving loan proceeds. The Association's payment options now encompass UnionBank, Landbank, Metrobank, BDO, alongside payment facilities such as SM Bills, Palawan Pawnshop Express Padala, LBC, GCash, Cebuana Lhuillier, and Maya Billspay.

Additionally, in pursuit of a streamlined frontline, middle, and back-end system, AFPMBAI initiated the ISO 9001:2015 Project Kick-Off and Orientation in October 2023. Partnering with Infocycle Solutions Inc as its consultant, this endeavor focuses on the administration and implementation of processes under the Death and Disability Benefit Section.

The Association maintained its leading digital presence across various platforms, including its official social media accounts on Facebook, LinkedIn, Instagram, X, and its website. Additionally, AFPMBAI persisted with its monthly radio program, MBAI-Connect, broadcasted on DWDD AFP Radio.



LEARNING AND GROWTH PERSPECTIVE

In taking human resource as part of the greatest asset of any institution, the Association has continued developing its manpower capability to offer best service, thru the conduct of several seminars, workshops and activities to ensure employee engagement, skills improvement, strengthening corporate culture, and building organizational capacity.

These were designed to equip all levels of employees—from frontline staff to supervisors, managers, executives, and members of the Board of Trustees—with the necessary skills and mindset to ensure AFPMBAI remains competitive and delivers excellent service to its members.

WAY FORWARD

Driven by AFPMBAI's service philosophy, which prioritizes the needs of its members, the Association will persist in delivering excellence and quality service. Anchored on key initiatives for the upcoming year, including the Financial Literacy Program, AFPMBAI CSR Program, Channel Development, Strategic Asset Management, Cost Management Program, Product and Services Development, Customer Relationship Management, Sales Force Recruitment, Process Optimization and Re-engineering, Innovation and Digital Transformation, and Human Capital Strategy, the Association remains committed to upholding good governance and ensuring member satisfaction.



SUMMARY OF THE GOVERNANCE REPORT

Beginning at the Board level, implementing governance best practices organizationwide remains a constant aim of the AFPMBAI. With the guidance of the IC and the ICD, the Association continues to adopt global governance standards in order to demonstrate to its members and stakeholders the value they hold for the AFPMBAI.

To improve its governance practices, in 2023 the Board of Trustees approved the conduct of an external party assessment of Board performance by commissioning ICD to evaluate how the AFPMBAI Board performed its duties and responsibilities for the year. The external assessment of Board performance has now been established as a practice to be conducted every three years in AFPMBAI.

The Internal Audit Office also conducted a Board Governance Practices Review through controlled self-assessment under the oversight of the Audit Committee, the results of which were presented to the Board with the intention of pointing out key areas of improvement that the Board could work on. These practices assure the



members of an objective performance evaluation of the representatives they elected, as well as a comprehensive review of the Board's work processes. The results serve as a guide for the members of the Board to continue improving on areas that may further be strengthened. Among the areas of improvement that were pointed out were the assessment of the performance of the Chief Risk Officer (CRO) and the Chief Compliance Officer (CCO), as well as Management's adherence to the submission of meeting materials. The performance assessment of the CRO and CCO has already been included in the AFPMBAI's Manual of Corporate Governance, while Management initiatives are being conducted in order to observe adherence to the submission of meeting materials.

Heeding the call for greater independence at the Board level, the Board also restructured its committees to assure a majority of independent trustees in the Governance Committee and the Audit Committee, while the Risk Oversight and Related Party Transaction Committee continues to be composed of a majority of independent trustees. This re-composition assures that Board decisions will be made with impartiality and with greater balance of business and stakeholder interests.

In compliance with the IC Circular Letter No. 2020-71 on the Revised Code of Corporate Governance for IC Regulated Companies, the Board also elected its Lead Independent Trustee in 2023 by electing to the position the Governance Committee Chairman and former Chief of Staff of the Armed Forces of the Philippines, Gen Ricardo A David Jr PA (Ret). Gen David has completed the Professional Development Program from ICD.

The Board and Management has demonstrated an outstanding performance for CY 2023. Detailed reports of this performance are found in the 2023 Governance Report, which has also been uploaded in the AFPMBAI website for viewing and evaluation.

And for the first quarter of 2024, the Board included in its Manual of Corporate Governance the rights that AFPMBAI has always upheld for its members. These rights are:



1. The right to be provided excellent products and services.

All AFPMBAI members are considered the most important stakeholders of AFPMBAI. They are entitled to receive quality products and services from the Association, delivered in a timely and efficient manner, subject to qualifications and procedures. All the AFPMBAI members have rights as embodied in the Bill of Rights of Policyholders based on Insurance Commission Circular Letter No. 2016-30.

2. The right to be informed.

The AFPMBAI shall keep its website and social media accounts regularly updated in order to provide information needed by the members to keep abreast of the activities, products and services, and operational status of the Association.

3. The right to participate.

All regular voting members have the right to participate in the decision-making process of the AFPMBAI through the Annual General Membership Meeting (AGM) conducted according to the provisions of the Bylaws.

All regular members also have the right to call for a special meeting of the members, subject to the conditions stipulated in the Bylaws.

4. The right to nominate.

All regular voting members have the right to nominate candidates to the AFPMBAI Board of Trustees, subject to the Nomination and Election Policy and the Rules on Nomination and Election published for every AGM.

5. The right to vote.

All regular voting members have the right to vote on all matters presented in the Order of Business or Agenda for the AGM. Voting may either be in person, in absentia, or by proxy in accordance with the Guidelines published for every AGM.

The tally of votes shall be announced during the AGM itself and the Minutes of the AGM, including the tabulation of voting results, shall be published in the AFPMBAI website not later than the following working day after the AGM.



6. The right to be heard.

The AFPMBAI opens all available communication channels to its members to receive their comments, complaints, inputs and suggestions. All regular voting members are also given the right to raise their concerns during the AGM by asking questions and airing their thoughts and ideas regarding AFPMBAI.

7. The right to receive feedback.

The AFPMBAI ensures that all queries sent by members through formal and accepted channels shall receive a response within 3-7 working days from the submission of required personal information for identity and system verification.

8. The right to be involved.

AFPMBAI values the ideas and experiences of its members with regard to their transactions and interactions with the Association, and encourages their involvement in improving AFPMBAI's products, services, and operations through suggestions and recommendations sent through e-mail (mail@afpmbai.ph), through its website (www.afpmbai.com.ph), or its social media pages in Facebook (AFPMBAIOfficial), Instagram (AFPMBAI), and X (formerly Twitter) (@AFPMBAIOfficial).

These improvements in AFPMBAI's governance best practices are geared toward increasing member confidence in the Association, in the Board and Management, and in our products and services. The Association has always emphasized that AFPMBAI members come first, and all governance efforts are conducted to bring to the members an assurance of Buhay na Panatag.





Report on the Audits of the Financial Statements

Our Opinion

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of Armed Forces and Police Mutual Benefit Association Incorporated (AFPMBAI) (the "Association") as at December 31, 2023 and 2022, and its financial performance and its cash flows for the years then ended in accordance with Philippine Financial Reporting Standards (PFRSs).


Responsibilities of Management and Those Charged with Governance for the Financial Statements
